Statement by Hong Kong Alliance for Advocacy Against Alcohol in response to 2024 Policy Address announcement to reduce alcohol tax

The Hong Kong Alliance for Advocacy Against Alcohol (the Alliance) is extremely disappointed at the announcement made in the Policy Address. The Alliance is very concerned about the negative impact on drinkers' health and their family, society, work productivity and long-term economic development brought about by any form of tax reduction that will encourage more people to drink alcohol and be exposed to its harm.
