

- 7. The World Health Organization (WHO) had called on countries to move towards primary care oriented health systems. Studies have shown clear advantages of health systems that rely more on primary care than specialist care.
  - a. List four (4) such advantages.(2 marks)
  - b. List four (4) essential elements for a primary care oriented health system to realize these advantages. (2 marks)
  - c. In reality, change towards a primary care-oriented health system that is able to realize these advantages in Hong Kong is not without major challenges. Describe such challenges in each of the following domains, and what measures the government may adopt / has adopted to overcome such difficulties.
    - i. Healthcare financing factors (2 marks)
    - ii. Healthcare financing factors (2 marks)
    - iii. Provider factor (2 marks)

8. The following table (Table 1) shows the annual attendances by triage categories of the Accident & Emergency Departments (AED) of all the public hospitals. The Hospital Authority proposed to Government to increase the AED attendance fee from \$100 to \$220 in order to curb the undesirable health service seeking behaviour. The Government eventually decided to increase the AED attendance fee to \$180.

9. The government has issued a public consultation document on the regulation of private hospitals. - c. Draft the Terms of Reference for the Medical Committee.(3 points)
- d. What members are essential to the formation of the Medical Committee? (1 point)

- 10. Accreditation and Regulation are different approaches to safeguard the quality of healthcare services. In Hong Kong many public and private hospitals have undergone hospital accreditation by Australian Council of Healthcare Standards (ACHS) and there are about 70 legislations governing healthcare organizations and healthcare providers in Hong Kong.
  - a. What are the differences between accreditation and regulatory approaches in ensuring quality? (3 marks)
  - b. Discuss on the benefits (4 marks) and weaknesses (3 marks) of the hospital accreditation system in enhancing the quality of healthcare services.
